CCDFS received a report that law enforcement and emergency medical personnel responded to a 9-1-1 call in reference to a near-drowning incident. It was reported the child had crawled out a doggy door and was found in the family's pool. She was pulled from the pool, and CPR was commenced. The child was transported to a local hospital where she was deemed to be in critical condition.

On 10/12/2019, CCDFS received notification that the child was pronounced deceased on 10/11/2019.
