A summary of the report of abuse or neglect and a factual description of the contents of the report: CCDFS received a report that the child was brought into a local hospital due to being in physical distress. Medical evaluation determined the child to be in critical condition. A concern was noted that there may have been a delay in seeking medical attention for the child.
- D. The date of birth and gender of child: 2/10/2004, Male
- E. The date that the child suffered the fatality or near fatality: 4/2/2019
- F. The cause of the fatality or near fatality, if such information has been determined: The cause of the near fatality is under investigation.
- G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so...

CCDFS has the following relevant prior history for this child and/or his family:

1/11/2000 – A report was received alleging abuse. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

8/11/2000 – A report was received with insufficient information to generate a report.

9/28/2000 – A report was received alleging abuse. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

10/2/2000 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

12/26/2000 – A report was received alleging abuse. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

2/22/2001 – A report was received alleging abuse and neglect, with additional information being received on 3/29/2001. Upon conclusion of a requisite investigation, the allegations were found substantiated. Appropriate services and referrals were provided to the family and the case closed.

5/15/2001 – A report was received alleging abuse and neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

11/19/2001 – A report was received alleging abuse and neglect. Court action was initiated and relevant family members were determined to be in need of protection. The allegations of neglect were found substantiated. The family was placed under formal supervision and a case plan put in place. Appropriate referrals and services were provided to the family. The court terminated wardship on 8/21/2002 and the case closed.

2/28/2008 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

12/12/2008 – A report was received alleging abuse and neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

10/15/2009 - A referral was received and was coded "Information Only."

9/24/2010 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

11/27/2010 – A referral was received and was coded "Information Only."

4/14/2011 – A referral was received and was coded "Information Only."

8/13/2012 - - A referral was received and was coded "Information Only."

1/22/2013 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegation was found substantiated. As a result of the report, the family was introduced to voluntary In-Home services. Appropriate services and referrals were provided to the family. During the course of the open case, another report was received on 4/22/2013 alleging neglect. This report was investigated and the allegation was substantiated. On 6/5/2013, the case was closed as the family no longer wanted voluntary In-Home services.

10/8/2018 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

11/13/2018 and 11/23/2018 – reports were received alleging neglect. Upon conclusion of a requisite investigation for each, the allegations were found unsubstantiated. The family was provided with a resource packet as well as an appropriate referral. The case was closed 12/28/2019.
