CCDFS received a report that emergency medical personnel responded to a local residence on a 9-1-1 call concerning an unresponsive teenager. The teenager was transported to a local hospital for treatment. Medical assessment determined her to be in critical, but stable condition.
- D. The date of birth and gender of child:**
10/9/2001, Female
- E. The date that the child suffered the fatality or near fatality:**
6/20/2019
- F. The cause of the fatality or near fatality, if such information has been determined:**
The cause of the near fatality is under investigation.
- G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so...**

This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.).

CCDFS has the following prior CPS history for this child and/or her family:

9/15/1999 – A report was received alleging neglect. CPS responded to the reported address in an attempt to make contact with the family. Upon appropriate inquiry, information was received that the family no longer resided at the address. Diligent search efforts were completed. Due to further unsuccessful attempts to locate the family, the case was closed.

7/5/2000 – A report was received alleging abuse. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

3/28/2002 – A report was received alleging abuse. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

7/21/2011 – A report was received alleging neglect. Based on the factual circumstances of the report, it was referred to an outside agency for assessment through the Differential Response program.

8/17/2011 – A report was received alleging abuse. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

4/25/2012 – A report was received alleging abuse. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

9/16/2014 – A report was received alleging abuse and neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

7/30/2015 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated. Appropriate referrals were provided to the family based upon assessment, and the case was closed.

12/16/2015 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

2/10/2017 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

4/16/2019 – A report was received alleging abuse. Child welfare action was taken and a referral was made based on family assessment. The case is under review and final disposition is pending.

CCDFS has opened an investigation as to the near fatality incident and family assessment is ongoing. CCDFS will, as deemed appropriate, continue to provide child welfare services, make referrals for child welfare services, and/or take action concerning the welfare and safety of the child.
