- B. Location of child at the time of death or near fatality (city/county):**
Las Vegas, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:**
CCDFS received a report that the child was in critical condition at a local hospital due to a suicide attempt. It was reported that 9-1-1 had been called and she was transported to the hospital by ambulance. Concerns were noted with regard to conflicting information received surrounding the near fatality incident, and difficulties in reaching the child's caregiver to obtain medical consent for her treatment.

- E. The date that the child suffered the fatality or near fatality:**
7/8/2019
- F. The cause of the fatality or near fatality, if such information has been determined:**
The cause of the near fatality is under investigation.

G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so...

CCDFS has the following prior history for this child and/or her family:

1/29/2019 – A report was received alleging abuse, with additional information being received 1/31/2019. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

3/19/2019 – A referral was received and was coded "Information Only".

3/20/2019 – A referral was received and was coded "Information Only".

3/21/2019 – A referral was received and was coded "Information Only".

6/21/2019 – A report was received alleging abuse. The case is open.

H. Whether the agency which provides child welfare services, in response to the fatality or near fatality...

CCDFS has opened an investigation with regard to the near fatality. Family assessment is ongoing. CCDFS will, as deemed appropriate, provide child welfare services, make referrals for child welfare services, and/or take action concerning the welfare and safety of the child.
