CCDFS has the following CPS history for this child and/or his family:

4/18/2015 – A report and an additional information referral were received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

CCDFS has completed its investigation and family assessment. The investigation found no evidence to support that the near fatality was the result of maltreatment, and the child is assessed as safe. The family was not in need of any services and/or referrals and the case has been closed.
