A summary of the report of abuse or neglect and a factual description of the contents of the report: CCDFS received a report that law enforcement and emergency medical personnel responded to a local residence on a 9-1-1 call of an unconscious child. By the time emergency medical personnel arrived on scene, the child was conscious. It was reported that the child had gained access to and ingested a cleaning agent that had been stored in a baby bottle and placed under the kitchen cabinet. Medical assessment of the child determined her to be in serious condition.

No maltreatment was found to be a factor in this near fatality incident.
