A summary of the report of abuse or neglect and a factual description of the contents of the report: CCDFS received a report concerning the teenager who was hospitalized at a local hospital after having experienced a medical episode relating to an underlying medical condition. The teenager was treated at another local hospital before being transferred and subsequently admitted for ongoing care. At the time of admission, she was initially assessed as being in critical condition. A concern was noted that several factors, including that the teenager had reportedly been provided with marijuana to smoke, had exacerbated her medical condition.

CCDFS has the following prior CPS history for this child or member of the child's family or household:

3/9/2015 – A report was received alleging abuse. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

6/10/2015 – A report was received alleging abuse. Court action was initiated in the matter. The allegation in the report was substantiated. The child who is the subject of this disclosure was not made a ward of the court and was determined to be safe in the care and custody of the non-offending parent. A case plan was put in place and appropriate services and referrals were provided to the family. The court terminated jurisdiction in the matter and the case closed.

8/12/2015 - A referral was received and was coded "Information Only".

12/1/2016 – A report was received alleging abuse. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated. The family was provided with an appropriate referral and resource guide for community services.

11/14/2017 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.
