INFORMATION FOR RELEASE

- A. Date of the notification to the child welfare agency of the death of a child:**
CCDFS was notified of the near fatality on 10/22/2019.
- B. Location of child at the time of death or near fatality (city/county):**
Henderson, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:**
On 10/22/2019, CCDFS received a report that, on 10/21/2019, law enforcement responded to a local residence on a welfare check after a 9-1-1 call that had been received was abruptly disconnected. Upon arrival at the residence, a child was observed to have sustained stab wounds. When officers encountered the adult caretaker, a struggle ensued and the caretaker was shot.
- The adult caretaker was transported to a local hospital and was later pronounced deceased. The child was transported to a separate local hospital and, upon medical assessment, was deemed to be in critical condition.
- D. The date of birth and gender of child:**
11/26/2012, Male
- E. The date that the child suffered the fatality or near fatality:**
10/21/2019
- F. The cause of the fatality or near fatality, if such information has been determined:**
The cause of the near fatality is under investigation.
- G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so...**

The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that is related to the fatality or near fatality incident. This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.).

CCDFS has the following prior history for this child or member of the child's family or household:

5/14/2019 – A report was received alleging abuse. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated. The family was provided with a community resource guide and the case was closed.

5/27/2019 - A referral was received and was coded "Information Only".
