- A. Date of the notification to the child welfare agency of the death of a child:**
11/11/2019
- B. Location of child at the time of death or near fatality (city/county):**
Las Vegas, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:**
CCDFS received a report that law enforcement responded to a local hospital due to a child death. Emergency medical personnel had responded to a local residence due to the newborn being unresponsive. The newborn was transported to a local hospital where lifesaving measures were taken, however they were unsuccessful.
- D. The date of birth and gender of child:**
11/10/2019, Male
- E. The date that the child suffered the fatality or near fatality:**
11/11/2019
- F. The cause of the fatality or near fatality, if such information has been determined:**
Release of the cause of the fatality will remain pending until receipt of official coroner documentation.
- G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so...**
- (1) The frequency of any contact or communication with the child or a member of the child's family or household before the fatality or near fatality and the date on which the last contact or communication occurred before the fatality or near fatality;

The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that is related to the fatality or near fatality incident. This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.).

CCDFS has the following relevant prior CPS history for the family and household:

3/3/2015 – A report was received alleging neglect. Upon completion of a requisite investigation, allegations were found substantiated. During the course of the open case, referrals were received on 4/15/2015 and 4/29/2015, and were coded "Information Only." Appropriate referrals were provided to the family and the case closed.

8/18/2015 – A report was received alleging neglect. Court action was initiated and relevant family members were determined to be in need of protection. The allegations were found substantiated. The family was placed under formal supervision and a case plan was put in place. Appropriate referrals and services were provided to the family. On 3/1/2018, the court terminated wardship and custody of the relevant family members.

7/31/2016 – A report was received alleging abuse and neglect. Court action was initiated, and a relevant family member was determined to be in need of protection. Allegations of neglect were found substantiated. The family was placed under formal supervision and a case plan was put in place. Appropriate referrals and services were provided to the family. On 2/7/2018 the court terminated wardship and custody.

5/23/2019 – A report was received alleging neglect. The case remains open.

H. Whether the agency which provides child welfare services, in response to the fatality or near fatality...

CCDFS opened an investigation as to the child fatality. Family assessment is ongoing with referrals and services being provided as assessment dictates. CCDFS will, as deemed appropriate, continue to provide child welfare services, make referrals for child welfare services, and/or take action concerning the welfare and safety of relevant members of the child's family or household.
