A summary of the report of abuse or neglect and a factual description of the contents of the report: CCDFS received a report that law enforcement and emergency medical personnel responded to a local residence relating to an unresponsive child who had possibly ingested an illicit substance during feeding. The child was transported to a local hospital, and upon medical assessment, was determined to be in serious/critical condition. The child's caregivers have been arrested in connection with the incident.
- D. The date of birth and gender of child: 9/5/2018, male
- Ε. The date that the child suffered the fatality or near fatality: 8/2/2019
- F. The cause of the fatality or near fatality, if such information has been determined: The cause of the near fatality is under investigation.

CCDFS has the following prior history for the family and/or household:

12/9/2003 – A report was received alleging neglect. Court action was initiated and a relevant family member was determined to be in need of protection. The allegations were found substantiated. The family was placed under formal supervision and a case plan was put in place. Appropriate referrals and services were provided to the family On 5/4/2006, a permanency plan was put in place. On 7/3/2006, the court formally terminated jurisdiction with the permanency goal for the child having been achieved, and the case closed.

2/18/2013 – A report was received alleging neglect. Court action was initiated and relevant family members were determined to be in need of protection. The allegations were found substantiated. The family was placed under formal supervision and a case plan was put in place. Appropriate referrals and services were provided to the family. On 2/10/2014, a hearing was held and the court terminated jurisdiction and wardship with a 432B.550(1)(a) Termination Order giving the appropriate parent sole, legal and physical custody of the children. The case closed.

5/13/2016 – A referral was received and was coded "Information Only

5/23/2016 – A referral was received and was coded "Information Only".

5/24/2016 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

9/2/2016 – A referral was received and was coded "Information Only".

2/1/2018 – A report was received alleging abuse. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

2/6/2018 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated. The family was actively engaged in community services. The family was provided with an appropriate information and a brochure, as well as a community resource guide. The case closed.

2/7/2018 - A referral was received and was coded "Information Only".

9/6/2018 – A referral was received and was coded "Information Only".

2/1/2019 – A referral was received and was coded "Information Only".
