7/5/2016

- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:**  
DCFS received a report that that law enforcement responded to a local residence where an infant was found not breathing.
- D. The date of birth and gender of child:**  
3/14/2016, male child
- E. The date that the child suffered the fatality or near fatality:**  
7/4/2016
- F. The cause of the fatality or near fatality, if such information has been determined:**  
The cause of the fatality is under investigation. Preliminary autopsy was conducted on 7/5/2016 with no evidence of trauma, however cause of fatality will remain pending until receipt of official coroner documentation.

**G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so:**

**3/13/2012 - report of negligent treatment - inadequate supervision was assessed by DCFS and found to be unsubstantiated. Family was offered family support services.**

**9/24/2013 - report of negligent treatment - inadequate food was referred to Differential Response.**

**10/29/2013 - report of physical injury/abuse was assessed by DCFS and found to be unsubstantiated.**

**2/13/2015 - report of negligent treatment - medical neglect was referred to Differential Response.**
