DCFS notified on 7/7/2019 child deceased.
- B. Location of child at the time of death or near fatality (city/county):**  
Elko/Elko County (declared in Salt Lake City, UT)
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:**  
The Division of Child and Family Services received a report on July 6, 2019 at 10:38 p.m. regarding 11-month-old infant. The infant had drowned in the bathtub, CPR initiated, and infant transported via ambulance to local hospital. The infant was then flown to Utah to a hospital and pronounced dead on July 7, 2019 at 7:45 p.m.
- D. The date of birth and gender of child:**  
August 16, 2018, Male
- E. The date that the child suffered the fatality or near fatality:**  
7/7/2019 Fatality
- F. The cause of the fatality or near fatality, if such information has been determined:**  
Cause of death penalty pending finding from medical facility.
