**A. Date of the notification to the child welfare agency of the death of a child:**

6/26/14

**B. Location of child at the time of death or near fatality (city/county):**

Reno, NV/Washoe County

**C. A summary of the report of abuse or neglect and a factual description of the contents of the report:**

On June 26, 2014 WCDSS received a report regarding a newborn male that was expected to die due to medical anomalies. He had remained at a local hospital since his birth two days prior. The newborn died later that night.

**D. The date of birth and gender of child:**

**E. The date that the child suffered the fatality or near fatality:**

**F. The cause of the fatality or near fatality, if such information has been determined:**

Child died due to prematurity and severe hydrocephalus

- G. 12/7/07 - Report received by DCFS Carson City Office regarding possible physical neglect and drug use by the parents. The investigation was unsubstantiated and the case was closed with no services provided.

1/11/08 - Report received alleging drug use by the parents. The report was coded as Information Only.

1/29/08 - Report received by DCFS Carson City Office regarding possible physical neglect and drug use by the parents. The investigation was unsubstantiated and the case was closed after referrals for community resources were made to the family.

9/1/09 - Report received by WCDSS regarding a newborn which was delivered at home and then taken into the ER. The mother and baby tested positive for marijuana. Worker made referrals and submitted vouchers for services, including a Comprehensive Substance Abuse Evaluation at ACCS, provided father with Narcotics Anonymous meeting list, employment resources and community resources list. The investigation was unsubstantiated and the case was closed.

9/24/10 - Report received alleging drug use by the parents. The report was coded as Information Only.

6/2/11 - Report received alleging possible physical neglect and drug use by the parents. The report was coded as Information Only.

4/11/14 - Report received regarding a pregnant woman being seen for a prenatal check. The reporting party was concerned she had missed many appointments and she is using illegal and legal drugs (prescriptions). The report was coded as Information Only due to the child not being born at the time of the report.

**H. Whether the agency which provides child welfare services, in response to the fatality or near fatality:** (1) Has provided or intends to provide child welfare services to the child or to a member of the child's family or household; and (2) Has made or intends to make a referral for child welfare services for the child or for a member of the child's family or household; and (3) Has taken or intends to take any other action concerning the welfare and safety of the child or any member of the child's family or household.

WCDSS conducted an investigation regarding this fatality and has since closed the case. Grief and loss referrals were offered to the family.
