A. Date of the notification to the child welfare agency of the death of a child:

1/11/15

B. Location of child at the time of death or near fatality (city/county):

Reno/Washoe County

C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

On 1/11/15 law enforcement and WCDSS were notified that an infant was found to be unresponsive by his parent. CPR was performed. The infant was transported to a local hospital where the he was pronounced deceased. No observable signs of trauma to the infant.

D. The date of birth and gender of child:

E. The date that the child suffered the fatality or near fatality:

F. The cause of the fatality or near fatality, if such information has been determined:

Undetermined.

G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so:

No contact with this family prior to the fatality as there is no CPS history.

H. WCDSS conducted a joint investigation with law enforcement. The sibling continues to be deemed safe at the closure of this investigation. Referrals for grief and loss were provided to the family.
