	On 8/28/18 infant was discharged from a local hospital for the first time. After midnight on 8/29/19 she was found to be unresponsive. Parents began CPR and called 911. The infant was transported to the local hospital where she was intubated. Life saving measures were performed.

WCHSA received a report on July 31, 2018 that newborn was born positive for opiates and amphetamines on July 30, 2018. The mother stopped getting prenatal care around 21 weeks due to issues with her medical insurance. Newborn was admitted to the neonatal intensive care unit. The case was open at the time of the near fatality.
