- A. Date of the notification to the child welfare agency of the death of a child: 11/27/18
- B. Location of child at the time of death or near fatality (city/county): Placer County, California. The family resides in Washoe County Reno, Nevada.
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:
- The child and her mother were returning from a medical appointment at an out of state hospital. The child did not feel well and 911 was called and the child was taken to the ER. Life saving measures were attempted at

the hospital by the ER medical staff however she was pronounced dead within two hours of her arrival by the ambulance.

- D. The date of birth and gender of child:
 - 3/5/01, female
- E. The date that the child suffered the fatality or near fatality: 11/26/18
- F. The cause of the fatality or near fatality, if such information has been determined:
- The child died as a result of complications from an underlying health condition. This is based off of medical information obtained.
