Officer called to the home on a report of a minor child with a gun shot wound.
- D. The date of birth and gender of child:
12/3/2003- male
- E. The date that the child suffered the fatality or near fatality:
June 27, 2019
- F. The cause of the fatality or near fatality, if such information has been determined:
Autopsy received indicating the cause of death to be a gunshot wound to the head, manner of death is undetermined at this time.

5/12/09- report received alleging inadequate supervision of children by their adult sibling. The report was coded as information only.

2/9/09- report alleging physical abuse was received and investigated. The report was unsubstantiated.

12/12/07- report alleging physical abuse was received and investigated. The report was substantiated.
