Child was found unresponsive in the home. Life saving measures were unsuccessful in the home.
- D. The date of birth and gender of child:

The autopsy has been received. Manner: Accident, Cause of Death: Suffocation due To Airway Obstruction of infant.

**August 2, 2019- information only report that child was born positive for marijuana. No other concerns for the family. No child welfare services were provided and a case was not open.**

The Agency has unsubstantiated the allegations and the case is being closed. Grief and loss services were offered to the family.
