Reno, NV Washoe County
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:  
The infant was found unresponsive and not breathing after being put to bed on a makeshift bed consisting of blankets and pillows, located on the floor. The family had been homeless and had been staying with friends.
- D. The date of birth and gender of child:

- E. The date that the child suffered the fatality or near fatality:

This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.).

**Prior History:** One prior report dated 9/30/2020. Report indicated that a home birth of a female child occurred and there were concerns of substance use by the parents. The case was closed as the agency was unable to make contact, despite numerous efforts to locate the family.

**H. Whether the agency which provides child welfare services, in response to the fatality or near fatality...**

WCHSA and law enforcement are working a joint investigation on this case. There are no other children in the home. Intensive immediate grief and therapeutic services were offered to the parents, but they declined the service.
