1. Call to Order – Megan Miller, Tim Burch, Judge Cynthia Lu, Amber Howell The meeting was called to order at 3:02 p.m. by Megan Miller.

3. Public Comment and Discussion:

5. <u>For Possible Action:</u> Committee Goals- Megan Miller, Tim Burch, Judge Cynthia Lu, Amber Howell Megan Miller stated a summary of the last meeting where the committee was in terms of training and technology was provided to Justice Saitta. Megan Miller stated regarding the workplan on prioritizing gaps in both training and data sharing, in the last discussion, in the North there was not any real organized best practices or evidence-based training. Megan Miller asked if there were any other gaps currently.

Judge Cynthia Lu stated she could not think of any. Judge Cynthia Lu asked Amber Howell if she had any thoughts on it.

Amber Howell reiterated she could not think of any either.

Megan Miller stated in the South the Court Improvement Project had done an 8-hour electronic training, all attorneys practicing there had to take. The training was basic child welfare law and practices. Megan Miller asked if it would be helpful for the North or if there is a need for it.

Judge Cynthia Lu stated they have new attorneys however it does not sound they are unclear on the law or have questions or issues. Judge Cynthia Lu offered to ask stakeholders at their next meeting if the attorneys would be interested in any type of refresher training.

Megan Miller stated in terms of training, she does not see any glaring gaps. In the last meeting Judge Cynthia Lu had mentioned there was an effort to try to get the DCFS system to communicate with the court system. Megan Miller asked if there were any other barriers relating to data sharing.

Amber Howell stated they currently have their INSPIRES and Prime initiative.

Judge Cynthia Lu commented she needs to follow up with the Court Improvement Program about the data sharing with UNITY.

Megan Miller stated the fourth action for April-June is to develop a presentation. Megan Miller suggested to hold off on that item until they have stakeholders present.

Amber Howell stated she agreed to wait on the presentation.

Megan Miller stated the next step would be to have some stakeholders present.

Judge Cynthia Lu stated she reached out to Keri Pruitt, their Education Liaison, however, has not heard back from her. Judge Cynthia Lu also stated she spoke with Liz Florez from Juvenile Delinquency and she indicated she would nominate an individual. At this time Judge Cynthia Lu has not heard back from Liz Florez.

Amber Howell stated she has a couple of foster parents whom are very interested.

Megan Miller suggested inviting Stephanie Cook and Amy Honodel as stakeholders to the next meeting.

Judge Cynthia Lu commented she had no objection to inviting them. Judge Cynthia Lu expressed concern about getting too large.

Megan Miller asked if they should only invite one attorney.

Judge Cynthia Lu stated it would work.

Megan Miller stated she has a potential CASA individual however she does not have a specific name. Tim Burch had mentioned reaching out to someone in education in the last meeting. Megan Miller stated she will follow up with Tim prior to the next meeting. Megan Miller informed she will prepare a questionnaire to help identify and survey the need for judicial reforms identified in the first step to review at the next meeting. Megan Miller asked committee members if they were ok with the questionnaire.

Judge Cynthia Lu and Amber Howell stated they were ok with it.

Megan Miller asked Elvira Saldana to add the item to the next meeting agenda.

Elvira Saldana acknowledged the agenda item.

Megan Miller stated they will continue to work on identifying specific individuals.

Amber Howell provided an update on the Prime implementation. It was scheduled to be launched on March 30th. There has been a delay and the launch date will now be mid-May.
