July 1, 2012- June 30, 2013

Specialized Medicaid Room and Board funding provides each local jurisdiction the ability to pay for per diem services for youth placed in a Medicaid approved facility. Additionally, local jurisdictions' have the flexibility to use this funding to provide community based programming to youth who are at risk for state correctional care.
