Departments of juvenile probation and state parole must provide these measures that assess the performance of probation and parole officers to DCFS:

- A decrease in the overall risk score from the initial YLS to any YLS reassessments;
- A decrease in the risk score from each of the eight domains (Prior and Current Offenses/Dispositions, Family Circumstances/Parenting, Education/Employment, Peer Relations, Substance Abuse, Leisure/Recreation, Personality/Behavior, Attitudes/Orientation) that pertain to a youth of the initial YLS to any YLS reassessments;

To assess the performance from referral to disposition, the following measures must be gathered by the juvenile court and provided to DCFS:

- The number of youth who have a parent/guardian (including an agency custodian) at hearings;
- The number of youth who have legal representation;
- The number of dispositions determined within 60 days;
- The number of detention hearings within 72 hours (per statute).

In addition to monitoring the State's overall and individual Counties' rates of recidivism, JJOC will review data to measure trends in:

Family Poverty Level
Percent of youth in the juvenile justice system with case plans
Decreases in re-arrest
Decreases in re-commitment
Decreases in violations of parole or probation
