## Information only: Nevada Human Trafficking Specialist roles and responsibilities

Legislation AB143 stated that DCFS is to appoint a Human Trafficking Specialist. This specialist is Karla Delgado, and her roles and responsibilities were addressed as the specialist. She is the point of contact.

### **Review of Assembly Bill 143**

This bill established the creation of this coalition. Priorities were discussed. Would like to have a resource list to share with the public from service providers. Service providers should email Karla, Andrea, and Nicole services and contact information for the coalition members to review and add to. Would like to have a section specific to children and one specific to adults. Include primary service area.

Is there a form for unity of information? Not at this time, but a form would be great to be created. Esther Rodriguez-Brown stated that she would be willing to assist to create this form and will send it to Karla, Andrea, and Nicole for review and use.

## **Coalition Membership**

## **Review of the CSEC Coalition**

## **HEAT Team**

A brief overview of the HEAT unit was shared. It's a relatively new unit as it was established January 2020. Provides a lot of training for varied groups. Email provided.

How closely are you working with the courts? Any interest in speaking with the judges? There is an interest in speaking with the judges and there was a training offered in 2021 that was well received. Judge Drakulich will reach out and have the HEAT team attend one of the meetings that the judges already have scheduled.

What are you seeing in the courts? Maximizing sentencing? Consistency would be key assistance that is needed in the court system.

## Southern Nevada Human Trafficking Taskforce

Power Point was shared, and this taskforce has been around for a while. Looking at improving services of this taskforce. Stats for services were shared on Human Trafficking assistance and outreach/trainings. Contact information was shared. What is pimp/john reversal – undercover officer identifies buyers for sex or get them in front of panderers/pimps and stop them from identifying victims and coercing them.

## **Upcoming Meetings**

Monthly meetings the last Friday of each month until the Coalition is established with subcommittees. Planning on this being monthly for the first quarter.
