Las Vegas, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:
CCDFS received a report that the child's adult caregiver contacted 9-1-1 for medical assistance due to the child exhibiting signs of physical distress. The child was transported to a local hospital where medical assessment deemed him to be in serious condition. A concern is noted with the caregiver's behavior at the hospital, as well as her overall management of the child's ongoing medical condition.
- D. The date of birth and gender of child:

- E. The date that the child suffered the fatality or near fatality:
10/19/2020
- F. The cause of the fatality or near fatality, if such information has been determined:
The cause of the near fatality is pending investigation.
- G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so...
 - (1) The frequency of any contact or communication with the child or a member of the child's family or household before the fatality or near fatality and the date on which the last contact or communication occurred before the fatality or near fatality;

The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that is related to the fatality or near fatality incident. This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.).

CCDFS has the following prior CPS history for this child or member of the child's family or household:

3/16/2015 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

3/14/2016 – A referral was received and was coded "Information Only".

3/14/2016 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

6/22/2017 – A referral was received and was coded "Information Only".

7/2/2017 – A report was received alleging neglect. Court action was initiated and the child was determined to be in need of protection. The allegation was found substantiated. The family was placed under formal supervision and a case plan was put in place. Appropriate referrals and services were provided. On 8/2/2018, a hearing was held and the court terminated jurisdiction and wardship with a 432B.550(1)(a) Termination Order giving the appropriate parent sole legal and physical custody of the child. The case closed.

H. Whether the agency which provides child welfare services, in response to the fatality or near fatality...

CCDFS has opened a case for investigation and family assessment. CCDFS will, as deemed appropriate, provide child welfare services, make referrals for child welfare services, and/or take action concerning the welfare and safety of the child.
