Las Vegas, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:
CCDFS received a report that the child had been found unresponsive in her bedroom by her adult caregiver. 9-1-1 was called and emergency medical personnel responded to the residence. She was transported to a local hospital where medical assessment determined her to be in critical condition, and she was admitted for ongoing care and treatment. A concern was noted with regard to the overall management of the child's health care needs by her adult caretakers.
- D. The date of birth and gender of child:
6/4/2003, Female
- E. The date that the child suffered the fatality or near fatality:
11/20/2020
- F. The cause of the fatality or near fatality, if such information has been determined:
The cause of the near fatality is under investigation.
- G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so...
- (1) The frequency of any contact or communication with the child or a member of the child's family or household before the fatality or near fatality and the date on which the last contact or communication occurred before the fatality or near fatality;

The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that is related to the fatality or near fatality incident. This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.).

CCDFS has the following prior CPS history for this child or member of the child's family or household:

10/27/2009 – A report was received alleging abuse. Upon conclusion of a requisite investigation, the allegations were found substantiated. Appropriate services and referrals were provided to the family, and the case closed.

4/16/2010 – A referral was received and was coded "Information Only".

10/6/2010 – A referral was received and was coded "Information Only".

1/30/2011 – A report was received alleging abuse. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated. Appropriate referrals were provided to the family, and the case closed.

4/8/2020 – A referral was received and was coded "Information Only".

4/16/2020 – A report was received alleging neglect, with additional information being received 4/20/2020. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

5/7/2020 – A report was received alleging neglect, with additional information being received 5/24/2020. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated. The family was referred for informal ongoing permanency services. The case closed 7/29/2020.

10/10/2020 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.
