  A report was received on December 4, 2020 that a 3-month-old infant was brought into the hospital by his adult caregiver due to the child exhibiting signs of physical distress. Medical assessment determined the child to be in critical condition. A concern was noted due to a lack of explanation for the child's condition. The child was transported to a larger hospital for further evaluation and treatment.

An update was received on 12.05.2020 that the child had died.
