WCHSA received a report of a near fatality on 11/9/2020. The youth was unresponsive at school and received life saving measures, and was transported to a local hospital where he was determined to be in serious condition.
- D. The date of birth and gender of child:  
2/3/2004 Male
- E. The date that the child suffered the fatality or near fatality:  
11/9/2020
- F. The cause of the fatality or near fatality, if such information has been determined:  
The youth ingested Fetanyl.
