Washoe County
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:
On December 10, 2020 WCHSA received a report 17-year-old male who overdosed on an unknown substance. The teen was found unresponsive and in serious condition. Emergency medical response initiated CPR. Medical personnel also administered Narcan, which the teen responded to immediately.
- D. The date of birth and gender of child:

- E. The date that the child suffered the fatality or near fatality:

Accidental overdose on Fentanyl

There have been two reports to the WCHSA:

April 6, 2004 – Allegations of a Threat of Harm as to the three children. The agency investigated found the allegation to be unsubstantiated.

August 27, 2020- A report was received and coded as Information Only.

The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that is related to the fatality or near fatality incident. This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.).

WCHSA submitted a referral for intensive in-home therapy to the family and collaborated with juvenile services agency for the teen as well as follow up with a residential treatment facility regarding the teen's mental health needs and services. The case is now closed.
