Behavioral Health Medicaid Service Manual (MSM) Policy Updates

Upcoming MSM 2900 – Federally Qualified Health Center (FQHC)

- Language added to clarify behavioral health services and requirements when delivered in an FQHC setting.
- January 30, 2024, Public Hearing

Upcoming MSM 400 – Mental Health and Alcohol/Substance Use Services

- Language added to clarify time and distance standards for mobile crisis response delivered by a DMCT and adding certification requirement for peers apart of the DMCT.
- January 30, 2024, Public Hearing

AB 137	 Revises provisions relating to fetal alcohol spectrum disorders. * Effective 1/1/2024
AB 138	 Provides Medicaid coverage for certain types of behavioral health integration services. *Effective 7/1/2024
AB 156	 Revises provisions relating to substance use disorders. * Effective 1/1/2024
SB 119	 Provides for the continuation of certain requirements governing insurance coverage of telehealth services. *Effective 11/29/2023
SB 191	• Makes certain changes relating to applied behavior analysis. *Effective 1/1/2024
SB 504 – Medicaid Budget	 Expansion of CCBHCs and New DHCFP Positions *Effective 1/1/2024 Elimination of Biofeedback and Neurotherapy for the treatment of a mental health diagnosis. *Effective 4/1/2024


