9. For Information Only. Katie Grace Foundation – *Kimberly Weingartner, President, Katie Grace Foundation*

Kimberly Weingartner spoke about the Katie Grace Foundation which honors her late daughter by re-distributing goods to non-profits organizations. Kimberly currently has about 25 non-profits that she provides goods to. Amazon is one of the foundation's main sponsors, providing about 15-20 pallets a week full of goods. Amazon initially donated over 4 million dollars to the Katie Grace (KG) Foundation. The KG Foundation has been able to save over 300,000 pounds of items from going to the landfill. Kimberly would like to help the rural areas by donating all sorts of goods from her foundation. 10. For Possible Action. Update on Pediatric Mental Health Access Care Grant (NVPeds) – *Nicole Mara, Education and Information Officer, Nevada Department of Health, and Human Services*

Nicole Mara provided information on participant attendance for multiple trainings that were being offered. For FY 2023, there have been 58 training opportunities up to date that have been offered by NVPeds with 628 total attendees. Between FY 2022 to now, NVPeds has had 109 professional development opportunities and 762 attendees overall. Nicole announced that multiple infographic's have gone out during the last month and encouraged all attendees to be a part of the listserv. NVPeds is in collaboration with National Alliance on Mental Illness (NAMI) Nevada and the Area Health Education Centers (AHEC) through the University of Nevada Reno (UNR) to promote pursuing higher education to 18 individuals between 18-24 years of age. interested in working with

children via primary or behavioral healthcare in hopes of further developing the workforce environment in those fields.

11. For Information Only. Update on System of Care (SOC) Grant – *Bill Wyss, Division of Child and Family Services (DCFS)*

Bill Wyss announced the Nevada Care Management Entity (CME) Request for Proposal (RFP) that is currently open for a four-year contract. This RFP is for the use of the American Rescue Funds by asking qualified vendors to provide a statewide CME for the delivery of services to child youth between the ages of 3 and 20 with complex behavioral needs who may be involved in multiple systems. This CME would serve as a centralized hub for the coordination of services for youth and families.

12. For Information Only. System of Care Subgrantee – Nye Communities Coalition– *DJ Mills, Director of Mental Health and Deflection Programs, Nye Communities Coalition*

DJ Mills described the mission of Nye Communities Coalition is to grow healthy organizations, people, and environments, by joining together individuals, organizations, agencies, and a cooperative and collaborative effort to increase services and opportunities. Nye Communities Coalition was established in December 2000 while being part of the Nye County School District Grant. The Coalition officially became a non-profit in 2002. In 2002, the Coalition was funded and accredited by the Nevada Bureau of Alcohol and Drug Abuse as one of 11 statewide prevention coalitions. This Coalition currently services Nye, Lincoln, and Esmeralda County. Currently, they operate more than 50 State and Federal Grants along with foundation and private donations, as well as some generated income. They offer mental, physical and wellness related training, workshops, and classes at no cost to the community. The Safe School Healthy Students Grant was received in 2016 which was the first big step into working with mental health. As of 2021, they are working to bring System of Care to rural and frontier communities to bring a higher level of mental health services within those areas. The purpose of the Nye Community Coalition and the Division of Child and Family Services (DCFS) working together is to partner up and build structures for an organized network of meaningful partnerships. The second objective is providing holistic case management to youth and families through screening with the Child and Adolescent Needs and Strengths Tool. The third objective is partnering with providers to deliver direct services in an evidence-based manner to youth impacted by emotional disturbances and mental illness. Fourth objective with the Coalition is working within communities to develop services and overcome barriers to access services for individuals in need. Lastly, the final objective is working collaboratively with communities to thoroughly access community response and emotional, mental, and behavioral health needs within Nye County.

14. For Possible Action. Updates from Medicaid – *Marcel Brown, Division of Health Care Financing and Policy (DHCFP)*

Marcel Brown gave the following updates for Medicaid.

- NV SPA 22-0005 – Reimbursement Methodology for Crisis Stabilization Centers remains on Resident Assessment Instrument (RAI) (continuing to pause the 90-day clock for Centers for Medicare and Medicaid Services [CMS]). Nevada has recently submitted drafted coverage SPA pages defining intensive crisis stabilization services to outline crisis stabilization services in general rather than emphasizing the location of where these services may occur. There is approved MSM Ch. 400 policy for Crisis Stabilization Centers.
- NV SPA 22-0023 Disaster Relief SPA for Certified Community Behavioral Health Clinics (CCBHC) remains on RAI (continuing to pause the 90-day clock for CMS). Supports Nevada in pursuing policy for state plan CCBHCs to remain receiving their anticipated PPS rates that were established pre-COVID pandemic, rather than having their PPS rates rebased to a lower rate due to the impact of their visit count during the pandemic. It is hoped to be approved soon.
- NV SPA 22-0002 – is a temporary support to maintaining the anticipated rate for CCBHCs, the Division is using NV SPA 23-0002 long term solution to this issue. NV SPA 23-0002 revises the bundled rate and Quality Incentive Payment methodology language and data submission requirement language.
- Upcoming SPA: Target Case Management (TCM) – The Division will be proposing to amend Nevada State Plan Amendment (SPA) Supplement 1 to Attachment 3.1-A Targeted Case Management to add in Nevada local county agencies as qualified providers under Provider Type (PT) 54 to deliver targeted case management services to adults with Serious Mental Illness (SMI). Currently county agencies are identifying Fee for Services recipients with SMI in need of case management services but are unable to be reimbursed for these services through Medicaid to assist. Current provider qualifications include state agencies and their employees or contractors, or an organization affiliated with the University of Nevada School of Medicine.
- Upcoming SPA: Alternative Benefit Plan (ABP) – The division will be proposing an amendment to the Alternative Benefit Plan (ABP) to add Medication-Assisted Treatment (MAT) as required within section 1905(a)(29) of the Substance Use-Disorder Prevention that Promotes Opioid Recovery and Treatment for Patients and Communities (SUPPORT) Act of 2018. This is already covered within Medicaid State Plan.
- Upcoming MSM 400: Mental Health and Alcohol and Substance Abuse Services Attachment B, C, and D – Proposed language will be included to align with the newly approved 1115 Substance Use Disorder Demonstration Waiver. Upon CMS approval of the Substance Use & Substance Use Disorders (SUD) Implementation Plan.
- Upcoming MSM 3800: Medication Assisted Treatment (MAT) – Removal of the Data 2000 waiver or “X” waiver requirement to prescribe Buprenorphine to align with recent federal guidance goal. May 30, 2023, public hearing.
- Upcoming MSM 400: Mental Health and Alcohol and Substance Abuse Services – Proposed new policy for mobile crisis response delivered by a Designated Mobile Crisis Team. Public workshop was held on March 31, 2023. Goal of May 30, 2023, public hearing.

- Upcoming MSM 2500: Case Management – Add Nevada local county agencies as qualified providers under Provider Type (PT) 54 to deliver targeted case management services to adults with Serious Mental Illness (SMI). Goal of May 30, 2023, public hearing.
- September 21, 2021, Nevada was among five states awarded the CMS SUPPORT Act Post-Planning Demonstration Grant Award
- Nevada will continue work identified under the Strategic Plan; Some major strategies include but are not limited to: Development of a new PT and individual specialties for Substance Use Treatment Providers and Nevada’s Section 1115 Demonstration Waiver application entitled “Nevada’s Treatment of Opioid Use Disorders (OUDs) and Substance Use Disorders (SUDs) Transformation Project”.
- 1115 SUD Waiver Demonstration Progress: 1115 application and authority approval were received from CMS on 12/29/2022. Once the SUD Implementation Plan is approved, it will be posted online. The submission of the drafted SUD Implementation Plan to CMS is pending an informal review. CMS approved an extension to formally submit the SUD Implementation Plan for 4/28/2023.
- Mobile Crisis Planning Grant: Work was initiated on the provider rate fee for Designated Mobile Crisis Teams and presented in public workshop along with Medicaid Service Manual additions during the March 31st public workshop. Draft coverage SPA language was submitted to CMS. Anticipate taking SPA updates and MSM Updates for DMCT May 30th public hearing for a requested effective date of July 1, 2023. Working closely with a fiscal agent to support this enrollment on development of a new Crisis Services Provider Type and several specialties, one being DMCTs, that should be implemented in May.
