Henderson, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:
CCDFS received a report relating to a domestic violence incident that occurred at a local family residence. During the incident, the child's adult caregiver fell while holding the child. As a precaution, the child was taken to a local hospital for evaluation. Upon medical assessment the child was determined to have sustained an injury and was in serious, but stable condition. An arrest was made as a result of the incident.
- D. The date of birth and gender of child:
12/14/2020, Male
- E. The date that the child suffered the fatality or near fatality:
1/24/2021
- F. The cause of the fatality or near fatality, if such information has been determined:
The cause of the near fatality is under investigation.
- G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so...
- (1) The frequency of any contact or communication with the child or a member of the child's family or household before the fatality or near fatality and the date on which the last contact or communication occurred before the fatality or near fatality;

CCDFS has the following relevant prior CPS history for this child or member of the child's family or household:

12/14/2012 – A report was received alleging abuse. Upon conclusion of the requisite investigation, the allegations were found substantiated.

2/13/2018 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegation was found substantiated.

11/3/2020 – A report was received alleging abuse and neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated.
