- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:**
DCFS received a report of Medical Neglect. Emergency medical personnel responded to a 9-1-1 call regarding an unresponsive infant. The infant was life flighted to a local hospital for treatment. The infant was born at home 2 months premature.
- D. The date of birth and gender of child:**
10-01-2021, male
- E. The date that the child suffered the fatality or near fatality:**
10-20-2021
- F. The cause of the fatality or near fatality, if such information has been determined:**
Unknown COD at this time. Pending receipt of medical records.
- G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so...**

This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.).

DCFS has no prior CPS history with this child or family.
