- B. Location of child at the time of death or near fatality (city/county):**
Las Vegas, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:**
CCDFS received a report that law enforcement and emergency medical personnel responded to a local residence on a 9-1-1 call relating to an unresponsive child. Life saving measures were commenced on scene and the child was transported to a local hospital. All lifesaving measures were unsuccessful, and the child was pronounced deceased. There is a concern of possible maltreatment.

- E. The date that the child suffered the fatality or near fatality:**
5/16/2022
- F. The cause of the fatality or near fatality, if such information has been determined:**
The cause and manner of death are pending official autopsy findings.
- G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so...**

The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that is related to the fatality or near fatality incident. This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.).

CCDFS has the following (*or has no*) prior CPS history for this child or member of the child's family or household:

10/6/2013 – A report was received alleging abuse and neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. The family was provided an appropriate referral based upon assessment. Relevant family members were determined to be safe, and the case closed.

9/19/2015 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. Based upon assessment, a referral was offered to the family, however, was declined. Relevant family members were determined to be safe, and the case closed.

5/16/2016 – A report was received alleging neglect, with a secondary referral also being received that was coded "Additional Information". Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. The family was determined not to be in need of services and relevant family members were deemed safe. The case closed.

5/5/2019 – A report was received alleging abuse and neglect. Court action was initiated, and relevant family members were deemed in need of protection. Allegations of neglect were found substantiated. The family was placed under formal supervision, case plans put in place, and appropriate referrals and services were provided. During the course of the open case, referrals were received on 10/17/2019 and 11/18/2020 and were coded "Information Only". On 5/5/2020, a hearing was held, and the court terminated jurisdiction and wardship with a 432B.550(1)(a) Termination Order giving the appropriate parent sole, legal and physical custody of the relevant family members. The case closed.

CCDFS has opened a case for investigation and family assessment.
