**B. Location of child at the time of death or near fatality (city/county):**

Las Vegas, Clark

**C. A summary of the report of abuse or neglect and a factual description of the contents of the report:**

CCDFS received a report that law enforcement and emergency medical personnel responded to a local residence on a 9-1-1 call relating to a child found unconscious in a pool. The child was transported to a local hospital where she was assessed as being in critical condition. There is a concern regarding supervision of the child.

On 8/27/2022, the child was pronounced deceased.

**D. The date of birth and gender of child:**

10/1/2019, Female

**E. The date that the child suffered the fatality or near fatality:**

Near fatality: 8/24/2022

Fatality: 8/27/2022

**F. The cause of the fatality or near fatality, if such information has been determined:**

The cause and manner of death are pending official autopsy findings.

**G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so...**

- (1) The frequency of any contact or communication with the child or a member of the child's family or household before the fatality or near fatality and the date on which the last contact or communication occurred before the fatality or near fatality;
- (2) Whether the agency which provides child welfare services provided any child welfare services to the child or to a member of the child's family or household before or at the time of the fatality or near fatality;

The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that is related to the fatality or near fatality incident. This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.).

CCDFS has the following prior CPS history for this child or member of the child's family or household:

7/17/2014 – A report was received alleging abuse and neglect. Court action was initiated, and the relevant family member was determined to be in need of protection. Allegations in the report were found substantiated. The family was placed under formal supervision, a case plan was put in place, and appropriate referrals and services were provided to the family. During the course of the open case, a referral was received on 7/29/2015 and was coded "Information Only". The court terminated jurisdiction on 10/14/2015 and the case closed.

9/28/2020 – A referral was received and was coded "Information/Referral".

4/7/2021 – A report was received alleging neglect. CCDFS responded to the reported address for the family; and upon appropriate inquiry, information was received that the family did not reside at the address. Attempts were made contact with the family at other reported addresses; however, this was unsuccessful. CCDFS conducted diligent search efforts to locate the family, including accessing relevant human services databases. Due to unsuccessful attempts to make contact with the family and insufficient information available to support the allegations, the allegations were unsubstantiated, and the case closed.

3/11/2022 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

4/29/2022 – A referral was received and was coded "Information Only".

5/4/2022 – Two referrals were received and were coded "Information Only".

5/12/2022 – A referral was received and was coded "Information Only".

5/18/2022 – A referral was received and was coded "Information Only".

8/18/2022 – A report was received alleging abuse and neglect. The case is open.

**H. Whether the agency which provides child welfare services, in response to the fatality or near fatality...**

CCDFS has opened a case for investigation and family assessment. Companion reports relating to other relevant household and/or family members were also opened as part of the investigation. CCDFS will, as deemed appropriate, provide child welfare services, make referrals for child welfare services, and/or take action concerning the welfare and safety of the child and/or relevant members of the child's family or household.
