- A. Date of the notification to the child welfare agency of the fatality/near fatality of a child:**  
10/23/2022
- B. Location of child at the time of death or near fatality (city/county):**  
Las Vegas, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:**  
CCDFS received a report that the child's adult caregiver found the child unresponsive in her crib. The caregiver sought assistance at a nearby health facility. A health professional administered CPR until emergency medical services arrived and transported the child to a local hospital. Medical assessment deemed the child to be in critical condition upon arriving. Lifesaving measures were unsuccessful, and the child was pronounced deceased. A concern is noted as the child's death is currently unexplained.
- D. The date of birth and gender of child:**

- E. The date that the child suffered the fatality or near fatality:**  
10/23/2022
- F. The cause of the fatality or near fatality, if such information has been determined:**  
The cause and manner of death are pending official autopsy findings.
- G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so...**
- (1) The frequency of any contact or communication with the child or a member of the child's family or household before the fatality or near fatality and the date on which the last contact or communication occurred before the fatality or near fatality;

  - (5) A summary of the status of the child's case at the time of the fatality or near fatality, including, without limitation, whether the child's case was closed by the agency which provides child welfare services before the fatality or near fatality and, if so, the reasons that the case was closed.

The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that is related to the fatality or near fatality incident. This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.).

CCDFS has the following prior CPS history for this child or member of the child's family or household:

11/11/2020 – A referral was received and was coded “Information/Referral”. An appropriate referral was made to a community resource.

11/23/2020 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegation was found unsubstantiated.

12/4/2020 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegation was found unsubstantiated.

7/16/2021 – A report was received alleging abuse and neglect, with a second referral received the same date that was coded “Additional Information. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated.

8/5/2021 – A referral was received and was coded “Information Only”.

CCDFS has opened a case for investigation and family assessment. CCDFS will, as deemed appropriate, provide child welfare services, make referrals for child welfare services, and/or take action concerning the welfare and safety of relevant members of the child's family or household.
