C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

On 1/8/2022, CCDFS received a report that the child was flown by helicopter from Mohave County, Arizona to a local Las Vegas hospital. Medical assessment of the child deemed him to be in critical condition, and he was not expected to survive the night. A concern is noted that the adult caregiver's explanation for the child's condition is not consistent with medical evaluation of the child.

On 1/10/2022, CCDFS received notification that the child was pronounced deceased on 1/9/2022.
