A summary of the report of abuse or neglect and a factual description of the contents of the report: CCDFS received a report that emergency medical personnel responded to a local residence on a 9-1-1 call relating to an unresponsive child. The child was transported to a local hospital emergency room where medical assessment determined him to be in critical condition, and he was admitted for ongoing care and treatment. Concerns have been noted regarding the child's underlying and current medical condition, as well as the ability for the caregivers to provide proper care for the child.
