 CCDFS received a report that the child was brought into a local hospital by her adult caregiver due to the child being in physical distress. Medically assessment deemed the child to be in critical condition and she was admitted to the hospital for further care and treatment. The child has an underlying medical condition, and a concern is noted regarding the overall management of the child's condition by her adult caregiver.

1/19/2022 - A referral was received and was coded "Information Only".

2/1/2022 – A referral was received, and based upon the factual circumstances of the report, it was referred for relevant services.
