- A. Date of the notification to the child welfare agency of the fatality/near fatality of a child:**

- B. Location of child at the time of death or near fatality (city/county):**  
Las Vegas, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:**  
CCDFS received a report that emergency medical personnel responded to a local residence on a 9-1-1 call concerning an unresponsive child. Upon medical assessment, the child was pronounced deceased on scene. There is a concern regarding the level of adult supervision present at the time of the fatality. Local law enforcement is investigating the event.
- D. The date of birth and gender of child:**  
12/14/2021, Male
- E. The date that the child suffered the fatality or near fatality:**  
5/1/2023
- F. The cause of the fatality or near fatality, if such information has been determined:**  
The cause and manner of death are pending official autopsy findings.

The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that is related to the fatality or near fatality incident. This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.).

CCDFS has the following prior CPS history for this child or member of the child's family or household:

2/25/2020—A referral was received and was coded "Information Only".

4/9/2021—A referral was received and was coded "Information Only".

4/30/2023—A report was received alleging abuse and neglect. The case is open.

CCDFS has opened an investigation with regard to the fatality incident, with actions being taken as family assessment dictates. CCDFS will continue, as deemed appropriate, provide child welfare services, make referrals for child welfare services, and/or take action concerning the welfare and safety of the relevant members of the child's family.
