- B. Location of child at the time of death or near fatality (city/county): Las Vegas, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

 CCDFS received a report that emergency medical personnel responded to a local residence on a 9-1-1 call regarding an unresponsive infant. The child was transported to a local hospital where she was determined to be in critical condition. There is a concern that the adult caregiver's explanation of the event surrounding the incident is not consistent with the medical findings. Law enforcement is investigating the matter.

The cause of the near fatality is under investigation.

CCDFS has the following relevant prior history for this child or member of the family and/or household.

12/12/2012 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated.

11/21/2018 – A report was received alleging abuse and neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated.

8/22/2020 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated.

10/24/2021 - A referral was received and was coded "Information Only.

3/30/2022 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. Based upon assessment, the family was provided with relevant referrals to community-based resources and services. The case closed.

9/10/2023 – A report was received alleging abuse and neglect. The case remains open.

CCDFS has opened an investigation with regard to the near fatality incident. On 9/12/2023, a companion report was opened for investigation relating to a secondary family residing in the home. CCDFS will, as deemed appropriate, provide child welfare services, make referrals for child welfare services, and/or take action concerning the welfare and safety of the child and/or relevant members of the child's family or household.
