B. Location of child at the time of death or near fatality (city/county):

Las Vegas, Clark

C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

CCDFS received a report that law enforcement and emergency medical personnel responded to a local residence on a 9-1-1 call relating to an unresponsive child. The child was found to be beyond resuscitation, and she was pronounced deceased on scene. The circumstances surround the child's death are currently unknown. There are possible concerns relating to supervision of the child.

D. The date of birth and gender of child:

E. The date that the child suffered the fatality or near fatality:

F. The cause of the fatality or near fatality, if such information has been determined:

The cause and manner of death are pending official autopsy findings.

G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so...

- (1) The frequency of any contact or communication with the child or a member of the child's family or household before the fatality or near fatality and the date on which the last contact or communication occurred before the fatality or near fatality;

The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that is related to the fatality or near fatality incident. This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.).

CCDFS has the following relevant prior CPS history for this child or member of the child's family or household:

5/17/2014 – A report was received alleging abuse. Upon conclusion of the requisite investigation, the allegation was found unsubstantiated.

12/19/2015 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegation was found substantiated.

2/13/2016 – A report was received alleging neglect, with a second referral also received that was coded “Information Only”. Upon conclusion of the requisite investigation, the allegation was found unsubstantiated.

12/18/2022 – A Referral was received and was coded “Information/Referral”. An appropriate referral was made to a community resource.

2/15/2023 – A report was received alleging neglect. A companion report for a secondary household was also opened. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. The family was provided information regarding an appropriate community resource. The case closed.

4/24/2023 – A report was received alleging neglect. A companion report related to another household was also opened. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated.

Referrals were received and were coded “Information Only” on the following dates: 8/9/2014, 8/15/2014, 8/18/2014, 9/20/2014, 9/20/2014, 5/1/2022, 3/30/2023, 4/3/2023, 4/7/2023, 4/10/2023 and 4/21/2023.
