C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

On 12/24/2023, CCFS received a report that law enforcement and emergency medical personnel responded to a 9-1-1 call regarding an unresponsive seven-year-old child who was reported to have been exposed to a controlled substance at an abandoned Hotel/Motel. It was further reported that the child was in the care of his adult caregiver who was on shift and worked at the site, and it was unknown how the child had become exposed to the substance. The child was transported to a local hospital where medical assessment deemed him to be in critical condition and it was confirmed that he was positive for a controlled substance. The child was able to be stabilized, however, remained unresponsive and in critical condition.

On 12/25/2023, the child was pronounced deceased.
