- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:**  
CCDFS received a report that emergency medical personnel responded to a 9-1-1 call regarding a child who was unresponsive and not breathing. The child was transported to a local hospital where he was pronounced deceased. Concerns are noted relating to the supervision of the child.
- D. The date of birth and gender of child:**  
4/1/2022, Male
- E. The date that the child suffered the fatality or near fatality:**  
3/19/2023
- F. The cause of the fatality or near fatality, if such information has been determined:**  
The cause and manner of death are pending official autopsy findings.
- G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so...**

The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that is related to the fatality or near fatality incident. This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.).

CCDFS has the following prior CPS history for this child or member of the child's family or household:

6/24/2020 – A report was received alleging abuse and neglect. On 8/27/2020, a second report involving an additional adult caregiver was received involving neglect. Court action was initiated in both instances, and a relevant

family member was determined to be in need of protection. Appropriate allegations in each report were found substantiated. The family was placed under formal supervision and a case plan was put in place. Appropriate services and referrals were provided. The case remains open regarding the relevant family member. On 4/1/2022, a report was opened alleging neglect following the birth of the child who is the subject of this disclosure. A separate court action was initiated in this instance, with the child being deemed in need of protection. The allegation was found substantiated. The family remained under formal supervision and a new case plan was put in place for the child who is the subject of this disclosure. Appropriate referrals and services continued to be provided to the family. The case remains open.

2/16/2021 – A companion report was opened alleging neglect. Upon conclusion of the requisite investigation, the allegation was found unsubstantiated.

CCDFS has opened a case for investigation and family assessment. CCDFS will, as deemed appropriate, provide child welfare services, make referrals for child welfare services, and/or take action concerning the welfare and safety of relevant members of the child's family or household.
