Las Vegas, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:
CCDFS received a report that the child's adult caregivers took the child to a local hospital emergency room after being directed to do so by a pediatrician. Upon medical assessment, and due to the seriousness of the child's condition, the child was admitted for ongoing care and treatment. A concern was noted for the overall care of the child by his caregivers.
- D. The date of birth and gender of child:

- E. The date that the child suffered the fatality or near fatality:

- F. The cause of the fatality or near fatality, if such information has been determined:
The cause of the near fatality is under investigation.
