  CCDFS received a report that law enforcement and emergency medical personnel responded to a local residence on a 9-1-1 call regarding an unresponsive child. It was reported that the child's adult caregiver went to the second adult caregiver's residence after work to pick up the child and another juvenile family member. It was reported the first caregiver found the child who is the subject of this disclosure unresponsive and called 9-1-1. Life saving measures were commenced on scene and the child was transported to a local hospital where he was pronounced deceased. There is a concern with the overall circumstances of the event and environment of the home.

CCDFS has the following prior CPS history for this child or member of the child's family or household:

11/10/2020 – A report was received alleging abuse and neglect, and a referral was received 11/12/2020 that was coded "Additional Information". Upon conclusion of the requisite investigation, the allegations were found unsubstantiated.

3/29/2021 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegation was found unsubstantiated. The family was provided with information regarding available community resources, and the case closed.
