- B. Location of child at the time of death or near fatality (city/county): Las Vegas, Clark
- **C.** A summary of the report of abuse or neglect and a factual description of the contents of the report: CCFS received a report that the child's parents allegedly kicked him out of the family residence and was staying with friends over a period of several days. Shortly after arrival at a friend's residence, he began to exhibit signs of physical distress and 9-1-1 was called. He was transported to a local area hospital where medical assessment deemed him to be in critical condition and he tested positive for marijuana and a controlled substance. He was admitted for ongoing care and treatment. Law enforcement responded to the event. There is a concern with regard to the circumstances surrounding the incident and initial inability to reach the child's parents.
- D. The date of birth and gender of child: 7/10/2007, Male
- E. The date that the child suffered the fatality or near fatality: 6/3/2024
- **F.** The cause of the fatality or near fatality, if such information has been determined: The cause of the near fatality is under investigation.
