- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

 CCFS received a report that the teenager was admitted to a local area hospital due to sustaining physical trauma. It was reported the child approached an unknown person requesting help. The person transported the teenager to the hospital where medical assessment deemed him to be in critical condition. Law enforcement was notified and responded to the hospital. There are concerns with the adult caregiver's ability to supervise the teenager.

The cause of the near fatality is under investigation.
