CCDFS received a report that law enforcement and emergency medical personnel responded to a local residence on a 9-1-1 call regarding a child who was found face down and unresponsive in the family's bathtub. The child's adult caregiver pulled the child from the tub and commenced CPR. Emergency medical personnel arrived and transported the child to a local area hospital where she was deemed to be in critical condition. On 6/29/2024, the child was pronounced deceased. There is a concern regarding supervision of the child. Law enforcement is investigation the event.
