- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:**
On 7/8/2024, CCFS received information relating to a child drowning that occurred 7/7/2024. It was reported that the event occurred while the child was attending a family gathering at the home of a relative. The child had been located unresponsive in the pool, was pulled from the pool, and life saving measures were commenced. Law enforcement and emergency medical personnel responded to the scene and the child was transported to a local area hospital where he was pronounced deceased. There are possible concerns with supervision of the child.

- E. The date that the child suffered the fatality or near fatality:**
7/7/2024
- F. The cause of the fatality or near fatality, if such information has been determined:**
The cause and manner of death are pending official autopsy findings.

The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that is related to the fatality or near fatality incident. This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.).

CCFS has the following prior CPS history for this child or member of the child's family or household:

5/17/1999 - A report was received alleging abuse. Upon conclusion of the requisite investigation, the allegation was found unsubstantiated.

6/8/2019 – A report was received and was coded “Information Only”.

10/17/2020 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. The family was provided with information regarding available community resources, and the investigation closed.

12/30/2021 – A referral was received and was coded “Information/Referral”. An appropriate referral was made to a community resource.

4/21/2023 – A report was received alleging neglect. Court action was initiated and the child and another relevant family member were determined to be in need of protection. The allegations were substantiated. The family was placed under formal supervision, a case plan was put in place, and appropriate referrals and services were provided to the family. On, 4/24/2024, the child and the other relevant family member were reunified with an appropriate caregiver, and an in-home safety plan was put in place. The case remains open for ongoing referrals and services.

H. Whether the agency which provides child welfare services, in response to the fatality or near fatality...

- (1) Has provided or intends to provide child welfare services to the child or to a member of the child's family or household; and
- (2) Has made or intends to make a referral for child welfare services for the child or for a member of the child's family or household; and

CCFS has opened a case for investigation and family assessment. CCFS will, as deemed appropriate, provide child welfare services, make referrals for child welfare services, and/or take action concerning the welfare and safety of relevant members of the child's family or household.
