 CCFS received a report that law enforcement and emergency medical personnel responded to a local residence on a 9-1-1 call indicting that the child's adult caregiver had found the child unresponsive in his crib. The child was transported to a local area hospital where he was pronounced deceased. There are concerns that there is no explanation for the child's death and the physical environment of the home.
